1. The NCI Agency, as the Host Nation, hereby gives notice of its intent to issue a Request for Quote (RFQ) to acquire Hardware equipment for a technology refresh.
2. A summary of the requirements of the anticipated RFQ is set forth in Annex A of this letter. The NCI Agency is refining the requirements and will include more details when the RFQ is released.
3. The reference for this RFQ is RFQ-CO-115724-CSSR-WP2 and all correspondence concerning this RFQ should reference this number.
4. The envisaged procurement procedure for this RFQ will be the BOA+ procedures. The successful quote, pursuant to the RFQ following this NOI, will be that quote that offers the lowest price and is technically compliant in accordance with the

evaluation criteria prescribed in the RFQ. The Purchaser may make multiple awards as a result of this solicitation (see Annex A for details).

5. Attached to this letter at Annex B is a list of NCIA BOA Holders considered potential bidders that may be able to provide the services and equipment required for this project.
6. The BOA+ procedures allow National Responsible Authorities to nominate eligible bidders in addition to the companies identified at Annex B. Any such nominations for companies that do not have an active BOA should come from the National Authorities via their Delegation/Mission to NATO, who will provide the requisite Declaration of Eligibility (DoE). Upon receipt of the DoE, the NCI Agency Contracting Officer will add the company to the Bidders List.
7. National Responsible Authorities are kindly requested to provide a list to the NCI Agency with Declarations of Eligibility, not later than **17 June 2022**, of qualified and certified companies which may be interested in receiving a Request for Quote for this project. The Declarations of Eligibility should include the following information for each of the nominated firms: **Company Name, Point of Contact, Telephone number and E-mail address**. This information is critical to enable prompt and accurate communication with prospective bidders and should be sent to the following address:

10. All Work and all Parts and equipment incorporated in the Work are to be new and of the most suitable grade of their respective kinds for the purpose, notwithstanding the requirements for testing, inspection and performance as required under the RFQ and the resulting Contract(s).

Annex A – Summary of Requirements

1. Introduction

As part of the Cyber Security System Refresh, the NCI Agency requires the acquisition of hardware that will provide a refresh, migration, and uplift to capabilities.

NCI Agency is requesting specific brands of hardware to align with existing implementations for support familiarity and to reduce additional training requirements.

2. Project Scope

The project scope under this RFQ will include the replacement of the following components with:

- (1) Server Hardware (Dell hardware)
 - a) Virtualized hosting infrastructure (with varying levels of TEMPEST certification).
 - b) Physical servers for non-virtualized services. (With varying levels of TEMPEST certification).
 - c) Racks cabling and ancillary hardware.
- (2) Storage Hardware (Dell hardware)
 - a) Storage (with varying levels of TEMPEST certification).
 - b) Backups (with varying levels of TEMPEST certification).
- (3) Network Hardware (Cisco hardware)
 - a) Switches (in Data Centre, with varying levels of TEMPEST certification).
- (4) Other Hardware & Cabling
 - a) Workstations (Dell hardware) (with varying levels of TEMPEST certification).

Also in the scope of each schedule is the following:

- (1) Support for 1 year and costed options for up to 5 years on the equipment being replaced.

Not in Scope:

Installation, configuration or implementation of the services to be hosted on the delivered hardware.

3. Geographical Implementation

The scope is limited to the NCSC (formerly NCIRC) Tier-2 systems and the central management of Tier-3, this is currently housed in 18 racks in Benelux.
