1. Notice has been given, through Reference E, of the NCI Agency's intent to request for solutions for ACPV. National Authorities have been invited to provide "Declarations of Eligibility" of qualified and certified firms which may be interested in receiving the solicitation package for this requirement, not later than Friday, 01 July 2022.
2. By this Amendment 2, the Closing Date for Nominations of Firms by their National Authorities has been extended to **Monday, 31 October 2022** and release of the solicitation package is anticipated to occur in **Q4 2022**.
3. Additionally, the NCI Agency anticipates to hold a second engagement with Industry. While participation will be voluntary, industry partners are encouraged to attend as we anticipate to provide updates related to ACPV and the envisaged procurement approach.
4. Details regarding the industry engagement such as venue, registration, date and time will be made available separately through a future Amendment to the NOI.
