 2. The purpose of this Amendment 1 is to:

 - 2.5. In response to the Request for Extension received from three Participating Countries, and in accordance with Reference C, the Bid Closing Date has been extended, the revised Bid Closing Date and time is:
 - 2.6. Thursday, 30 July 2026 at **12:00 hours Central European Time (CET)**.

3. By virtue of this Amendment 1, the enclosed documents replace and supersede all previous version issued in the context of this IFB-CO-422181-ASNMC.
4. **In accordance with Reference B, the Prospective Bidders are reminded that any additional questions are limited only to the information provided as answers by the Purchaser (para. 2.1 above). Such additional questions shall arrive no later than fourteen (14) calendar days before the revised BCD.**
5. Prospective Bidders are advised that the NCI Agency reserves the right to cancel, withdraw, or suspend this IFB at any time in its entirety without incurring any repercussions, or liabilities.
6. The NCI Agency bears no liability for solicitation preparation costs incurred by firms or any other collateral bid preparation costs.
7. Except as provided herein, all other terms and conditions of IFB-CO-422181-ASNMC documents remain unchanged.
