Introduction

The NATO Communications and Information Agency (NCIA) hereby provides notification of the following Procurement Opportunity in accordance with the Procedure for NATO Competitive Procurement ([link](#)). This notification is issued to foster open and fair competition among eligible vendors from participating nations. This notification does not constitute a commitment to award a contract.

Vendors are invited to review the requirements described herein and to submit their bids in accordance with the instructions provided in this notification and subsequent solicitation documentation. All interested vendors are reminded that timely registration and compliance with eligibility requirements are essential, as deadlines for submission may not be extended. Vendors are advised to regularly check for updates to this notification.

This opportunity reflects NATO's commitment to transparency, equal treatment of suppliers, and the efficient delivery of goods, works, and services in support of NATO missions and participating nations.

All eligible and responsible sources may submit a quotation, bid, or proposal, which shall be considered by the NCIA.

1. Title of Procurement Opportunity

Commercial Cloud Service Provider (CCSP) Marketplace, with the immediate requirement to support the Protected Business Network (PBN).

2. Description of Requirement

NCIA intends to establish a CCSP Marketplace to provide access to commercially available Infrastructure-as-a-Service (IaaS), Platform-as-a-Service (PaaS), and related cloud services required to support current and future NATO enterprise workloads.

The immediate requirement is to provide commercially available CCSP services in support of PBN.

Detailed technical, operational, security, contractual, and evaluation requirements will be provided within the formal solicitation documentation.

3. Vendor Eligibility

Participation in this Procurement Opportunity is restricted to vendors from participating NATO nations.

4. Access to Solicitation Documentation

Interested vendors may participate to and access the solicitation documentation for this Procurement Opportunity as of the Anticipated Solicitation Release Date as follows:

- a. Vendors must obtain a valid Declaration of Eligibility (DoE) through their National Authorities in order to be included in the Bidder's List and to participate should the solicitation be issued.
- b. A template of the DoE is provided in the Annex to this NPO for reference and

completion.

- c. The prospective Bidder is responsible for arranging for their National Authority to complete the form. The signed DoE must be transmitted directly by the National Authority to the Point of Contact (PoC) identified in this NPO.
- d. The DoE must be received by NCIA's PoC not later than 2 September 2026, which is 35 calendar days after the date of this NPO.
- e. Prospective Bidders are advised to initiate this process early, as NCIA cannot request or obtain a DoE on behalf of a prospective Bidder. Failure to ensure that a valid DoE has been received by the PoC may result in exclusion from the solicitation process.

5. Security Requirements

This opportunity is classified as NATO UNCLASSIFIED (NU) and interested vendors are required to meet the above-mentioned security level.

Draft contract Terms and Conditions: this is provided to obtain early industry feedback on the proposed contractual framework, identify any provisions that may materially affect competition, pricing, risk allocation or service delivery, and allow the Purchaser to consider appropriate refinements before issuing the formal solicitation.

Both documents are preliminary, non-binding and subject to revision.

- b. Interested suppliers are invited to submit a Capability Statement and Feedback Response, not exceeding five pages, addressing the following:
 - i. Corporate profile and relevant enterprise cloud experience;
 - ii. Experience delivering commercial cloud services to government, defence, or similarly regulated organizations;
 - iii. Relevant certifications, accreditations, and global support capability;
 - iv. Feedback on the draft notional scenario, including whether the service categories, volume metrics, assumptions, and proposed consumption profile are clear and suitable for pricing and evaluation purposes;

- v. Feedback on the draft Terms and Conditions, including any provisions that may materially affect competition, pricing, risk allocation, data sovereignty, security compliance or service delivery;
 - vi. Any commercial, technical, or contractual considerations NCIA should address before release of the RFP.
- c. Capability Statements and Feedback Responses are requested solely to support market research and procurement planning. They will not be evaluated for contract award purposes.
- d. Following review of Capability Statements and Feedback Responses, NCIA may invite suppliers to participate in one-on-one sessions in order to clarify any of the information provided by the supplier.
- e. Participation in one-on-one discussions is optional and will not constitute qualification for, or provide any competitive advantage in, the subsequent procurement. NCIA may limit participation in such meetings based on the relevance of supplier capabilities, experience, and feedback received.
